**Updated June 19, 2020**  
**Daily/Weekly/ Monthly Camping: Summer 2020**  
**Re: Covid 19 Operational Changes**

*As of May 15th we were open for seasonal customers. Beginning May 17<sup>th</sup> we were open for NH residents only. As of May 29th we opened some bath houses, and now we have opened all bath houses. As of June 12<sup>th</sup>, Out of state residents may camp if they can sign a waiver that they have quarantined at home for 14 days prior to arrival.*

Welcome! When you come in to register for camping, you will sign your check-in sheet which will state that you have read these guidelines and that you understand your responsibility to comply with these operational changes. All reservations must be paid in full before arrival. A check-in packet will be provided for each campsite by campsite number and name of registrant. A staff person will be available either on the deck or in the office to check you in, to answer questions, and take orders for campfire wood, ice, etc. A current credit or debit card will be needed to be kept on file for each site during your stay to cover the gate card deposit ( \$20 charge if not returned), or for any curbside orders from our campground store. Store is open for purchases or browsing (mask please).

1. I will stay home if I or anyone in my family is sick or has had a fever in the last 48 hrs, has sore throat, cough or shortness of breath, muscle aches, chills, severe fatigue or sudden loss of sense of taste or smell. I will call to cancel my reservation and will arrange to reschedule my visit or I may elect to receive a refund.
2. I understand that when I register for my site, only those family members who come with me for this trip will be allowed to occupy my site. (No more than four adults and four children under age 18 can be included). NO other day or overnight visitors will be allowed in the campground.
3. I will bring from home all food and supplies needed for my stay. I understand that campfire wood must either be purchased at the campground or brought from Carroll County sources only. Absolutely NO construction or pallet wood may be brought in or burned in the campground.
4. I understand some common areas of the campground will be closed for a period of time. These areas include but are not limited to: the playground; the shuffleboard courts; the mini-golf. My check-in packet will include information regarding activities happening at the campground and in the immediate area which may be enjoyed following social distancing guidelines. Use of the Swift River for wading, tubing swimming and fishing is allowed. (Waterfront site occupants may go directly into the water. Others must use the beach for access.)
5. When I travel to stay at my campsite, I will be following the CDC guidelines requiring social distancing of 6 ft. from anyone not part of my family, and I will not be part of any group gathering of more than 10 people. Frequent hand washing will be enforced at my campsite for all occupants. When any of our party leave the campsite to walk on the grounds, we will each have a mask to wear according to CDC guidelines. (Guidelines from the NH Division of Public Health regarding face masks are available upon request.)
6. I will supervise children under age 18 in my party to ensure they follow all guidelines for social distancing, all campground rules, and particularly that they do not enter or play at areas that are lined off or posted CLOSED. For in-store purchases, children under age 12 must be accompanied by an adult.
7. I understand that non-compliance with these or any posted guidance may result in my being sent home.

8. I understand that the campground will communicate with me regarding any changes in operations via signs within the campground, Facebook postings, e-mail or regular mail messages, or phone calls.
